INFORMATION DOCUMENT FOR A PERMIT TO BUY / SELL / DONATE / RECEIVE AS A DONATION AND TRANSPORT A WILD ANIMAL (NOT GAME) WITHIN THE PROVINCE

I, the owner, and I, the receiver, and I, the transporter, hereby declare that I take note of and understand:

- That the onus is on me to acquaint myself with all legislation pertaining to the hunting, capturing, transport, trading and possession of wild animals and wild animal carcasses.
- That the onus is on me to acquaint myself with all legislation pertaining to the international movement (import / export) of wild animals and wild animal carcasses and that additional permits (e.g. CITES) may be required.
- That I can apply for permits at my nearest CapeNature regional office.
- That I must have the necessary permit in my possession prior to commencing any activity with a wild animal.
- That any permit has an expiry date and that the onus is on me to apply for the renewal of any permits at least fifteen (15) working days prior to the expiration.
- That a transport permit does not authorise me import / export a wild animal or a wild animal carcass.
- That a transport permit does not authorise me to keep a wild animal in captivity.
- That the receiver of the wild animal(s) must apply for a captivity permit within 30 days of receipt of the wild animal(s).
- That a transport permit does not authorise me to transport or trade in endangered wild animals or their carcasses.
- That a transport permit is valid for one consignment only.
- That the transport of live wild animals must be done in accordance with the Animal Protection Act of 1962 and container / enclosure / cage specifications must adhere to the International Air Transport Association's Live Animals Regulations.
- That it is an offence to commence any activity with a wild animal without being in possession of a valid permit and / or license authorising that particular activity.
- That there are legislation (Regulations published in Provincial Notice 955 of 1975) prescribing the minimum cage sizes for wild animals and that it is an offence to keep any wild animal in a cage which does not meet the minimum prescribed size.
- That I have been informed of the existence of the Fencing Policy and its implications and that the onus is on me to acquaint myself fully of all the requirements and prescriptions of this policy
- That in certain cases I may need additional permits from Veterinary Services and/or the municipality (e.g. for the transport of certain wild animals or the keeping of poisonous snakes and primates in municipal areas etc.).
- That the onus is on me to determine whether any of the species of wild animal(s) that I am applying for is listed as an alien and invasive species as per the National Environmental Management: Biodiversity Act (10/2004): Alien and Invasive Species List. No permit issued by CapeNature exempts me (the holder thereof) from complying with the National Environmental Management: Biodiversity Act (10/2004): Alien and Invasive Species Regulations.
- That I can be held responsible for reimbursement of the costs incurred by CapeNature to conduct an inspection if the minimum requirements for a permit / license are not met.
- That, in the case of repeated offences or failure to comply with permit conditions, it may lead to the cancellation of permits / licenses and/or the withholding of future permits / licenses.
- That, in the case of an offence regarding the wild animal(s) contained in this application, the wild animal(s) may be confiscated / seized by CapeNature.
