

AFFIDAVIT

I, the undersigned,

ROBYN GOUVEA
(ID: 930721 0109 088)

do hereby make oath and state that:

1. I am an adult, female business owner residing in Valmary Park, Durbanville.
2. The facts and allegations contained herein are, save where the context clearly indicates to the contrary, within my own personal knowledge and are to the best of my belief both true and correct.
3. On the 16th April 2023 at approximately 18:15 my friend, Victoria Thompson, and I were walking her dog around our neighbourhood. We walked down Lindenberg Road and into De Villiers Road. As we approached the driveway of 87 De Villiers Road (In Durbanville), at approximately 18:20 their motor gate opened and a minor child walked out of their property carrying a squirrel by its tail. He threw the squirrel onto the greenbelt opposite their property and ran back into their yard. We could hear the distinct sound of an air-gun being discharged coming from their yard.
4. We went to investigate the body of the squirrel and found what appeared to be a bullet hole in its chest. It also had blood coming out of its mouth.
5. In my presence, Victoria then contacted the Society for Prevention of Cruelty to Animals on their emergency line and reported it. She informed me that she needed to place the squirrel into a packet and that their inspector would collect the body from her. She went to drop her dog off and retrieve a packet while I waited with the squirrel.
6. She also contacted the local Neighbourhood watch, in my presence, to request the camera footage of the minor child throwing the squirrel onto the greenbelt and running back into their yard.
7. There were several male adults present during this time in the yard of 87 De Villiers as you could see them from the road.



8. Not only is this blatant cruelty to animals, but what would have been the outcome if one of the stray bullets had injured myself, my friend or her dog while walking past their property.
9. This property also has owls residing in the trees in/around their yard, which to the best of my knowledge, are a vulnerable species; if they shoot at and maim squirrels what is to prevent them from killing other species.
10. We reside in a low density neighbourhood and our community is one who loves animals and loves the presence of squirrels in the area. These squirrels do not make a nuisance of themselves, nor is the area overpopulated with them. This was a blatant act of cruelty for entertainment.
11. The adults present have risked the safety of those living in and around their property by failing to observe basic safety practices by discharging an air gun in a residential area; they are also teaching their children that no respect is needed for animals, who are sentient beings and that no respect for the law is required.
12. It is my hope that the Honourable Court ensures they face the full might of the law in this case.
