3. Regulation of breeding

(1)

All dogs and cats (male and female) over six months of age must be sterilized, unless the owner obtains a permit from the City to keep the animal unsterilized.

(2)

An application to keep an unsterilized animal, must be in writing on a prescribed form, in accordance with relevant City Policies and Standard Operating Procedures and must be accompanied by the prescribed fee.

(3)

An authorised official may cause an animal to be sterilized and the costs thereof may be recovered from the owner, should he or she deem it necessary—

(a)

in the interests of the welfare of the animal;

(b)

to prevent nuisance;

(c)

when the animal is stray;

(d)

at the request of the owner; and

(e)

pursuant to the seizure and impoundment of the animal or a contravention involving the animal.
