

SWORN AFFIDAVIT

I, **Emma Neville** with ID number **8109190232083**, an adult female of 43 years of age and on cell phone number **0825671400** states under oath / affirm in English:

1.

On the afternoon of 17 October 2024 at approximately 16h00 at the False Bay Rugby Club in Constantia, I witnessed my friend Clare Templeton coming towards me with a Jack Russell dog on a lead. She told me that she had found this dog running around the busy parking lot and almost being hit by two cars. My two daughters (aged 7 and 10 years) and their two friends (aged 8 and 5 years) immediately took kindly to this little dog and happily walked around the field looking for its owner.

My daughters and their friends came to tell me that they had located the owner, and he was sitting inside the Toad restaurant (situated at the Rugby Club). I accompanied my daughters and their friends inside to return the dog to its owner. Upon walking to table, I said to the man we have found your dog. He proceeded to swear about the dog telling me and the small children that he "did not care if the dog gets run over". He referred to the dog as a "dickhead" and an "arsehole". He was extremely inebriated. I said to the man he is not to speak like that in front of children and I hung the dogs lead over the chair in front of him. I walked out with my children and their friends and complained of his rudeness to the waiter.

As I was watching my children play on the field, a friend then called to inform me that the SPCA had arrived and that the man was stopped from leaving. I accompanied my friend Clare to the parking lot, and I witnessed the man calling his dog "Rat dog go find your fucking shit." The man seemed completely inebriated and in the space of time we had returned his Jack Russel-type dog, he had managed to lose his second dog and was about to drunkenly get into his vehicle and drive off.

The SPCA parked his vehicle behind the man's vehicle to stop him from leaving in his intoxicated state. The one dog was tied on the back of the man's bakkie. Officers of Law Enforcement arrived to assist the SPCA official. The man became extremely aggressive and tried to obstruct the officers from doing their work. The man also started swearing at us and tried to intimidate us as well. The man got out of control and the Law Enforcement officers had to restrain the man for his and others safety as he was out of control.
