They told us that they decided to remove the dog from the vehicle as all four windows were open and the car was parked in full sun. I went to the car and observed no water provided for the dog and he defecated in the back seat.

I left a warning on the windshield to:

1) It has been alledged that your dog has been left in your vehicle unattended since apprcimately 10h20 without water at apprcimately 23 degrees in the sun. Refrain from taking your dog with on extended visits and it is advised that the dog is attended by someone at all times with access to water.

I yold the complainants to bring the dog in for safekeeping if the owner has not arrived by the time they finished their food.

At approximately 11h10 we received a message from the complainant to let us know that the owner arrived.
