You are hereby warned that:

1. No person shall use any animal for safeguarding or permit any animal to be used for safeguarding of which he is the owner or has the lawful custody, unless such person is the holder of a valid licence in terms of the Performing Animals Protection Act 24 of 1935, as amended in 2016.

Please refer to Section 1 of the Performing Animals Protection Act 24 of 1935:

1. Restriction on exhibition and training of performing animals and use of animals for safeguarding.—No person shall exhibit or train or cause or permit to be exhibited or trained for exhibition any animal of which he is the owner or has the lawful custody or use any animal for safeguarding unless such person is the holder of a licence.
[S. 1 substituted by s. 1 of Act No. 7 of 1991.]

- a. Should you not be in possession of a valid Performing Animals Protection Act Licence then you are not permitted to use any animal for safeguarding and must forthwith cease to use any such animal for safeguarding to avoid further action and/or criminal prosecution.
 - b. Kindly forward a copy of your valid Performing Animals Protection Act Licence **within 48 hours** to our office by email to inspmanager@spca-ct.co.za
2. Dog handlers on site were not able to produce a valid DH qualification during the inspection. The dog used for safekeeping was found running off-lead during the inspection which the guard is not qualified to permit. You need to provide relevant documents of the dog handlers for this site within **48 hours**.
 3. The SPCA was informed that the dogs stay on the site. You need to provide a suitable relief camp for the dogs for when they are not on shift and provide environmental enrichment in the camp. You have **14 days** to do so.
 4. Dirty conditions inside and around the enclosures.
 - a. There was build-up of old hair and sand found inside the enclosures. You need to ensure that cleaning is done thoroughly and the kennels need to be moved at least once a week to deep clean underneath them. You have **72 hours** to do so.
 - b. The area around the enclosures were surrounded by overgrown bush. You have **72 hours** to trim and clean the surrounding areas.

5. The middle enclosure was observed to be stuck in the sand so it needs to be lifted to avoid any dirty and/ or parasitic conditions from arising. You have **14 days** to do so.
6. The SPCA was informed that 5L water is delivered to the site every 3 hours, for 3 adult dogs. This is unacceptable because the dogs need to have access to water 24/7. You need to ensure that this is rectified immediately and that the dogs have access to water 24/7.

We remind you to adhere to all the provisions of the Animals Protection Act 71 of 1962, Performing Animals Protection Act 24 of 1935 (as amended in 2016).

This warning has been issued in terms of the Society for the Prevention of Cruelty to Animals Act 169 of 1993.

Failure to comply with this warning may render you liable for prosecution under the Animals Protection Act 71 of 1962 and/or Performing Animals Protection Act 24 of 1935.

Any person who:- obstructs, hinders or resists an officer authorised in terms of the Animals Protection Act 71 of 1962 or conceals any animal shall be guilty of an offence in terms of Section 8(4) of the aforementioned Act.
