Upon inspection, i met with Heidi. There are 2 adult dogs and 1 puppy on the property. The dogs were free roaming on the property. They had access to water and a clean living environment. They had access to adequate shelter.	
Heidi explained that the person selling the puppies stay in Joberg and that they just keep and look after the puppies for the people that want to buy the puppies that stay in Cape Town. She told me that the puppies appeared to be fine for the few days that they looked after the puppies but then found out that 2 puppies that were sold hot parvo. They then took the other 2 puppies to AACL Epping where the 2 puppies were admitted but unfortunately died. She stated that they made contact with the seller who told them that the puppies were healthy when he did send them down to Cape Town and his other dogs are fine so she believes that the puppies might have gotten the virus on the plain while flying to cape Town. She stated that at she was concerned that her own puppy will get the virus as she only have 2 vaccines and has	

disinfected the property with F10, which she showed me. She also said that they are not gonna look after more of the sellers puppies. All the dogs on the property appeared in a fair condition and good health. She told me that they are leaving for holiday and the puppy won't be at the property and will only return around the 3rd of January.
