On my arrival, i have met with woman who Introduced herself as Nameless Johnson (the complainant) she allowed me onto the property.

I started to inspect her dogs, she owned a lot of dogs, there were two adult dogs as follows, a mother dog called Blacky, she is black and white, she is 2 years old. The dog appeared to be in a fair condition, she had 7 puppies, that appeared to be in a fair condition.

The was a male pitbull that is tan white p his name chocolate, 12 months old, the dog appeared to be in a fair condition.

On the other side there were five puppies, as follows
 1. Male Cross breed black tan and white, called Master,
 2. Male Cross breed black and white, called Diamond.
 3. Male Cross breed black and white called Scoobdoo.

4. Female Cross breed black white callee Ice.

5. Female cross breed called Layla black and white. All the above puppies are 5 months old, they were separately, as the owner claimed tha, she doesn't want her dogs to be with dog called Meisy because of her condition.

I wanted to know from Nazeel, her plans with regard her dogs, as I was looking at the high number of the dogs, she said, her plan to is to keep them, as she doesn't have children, I told her that is not a good idea, as she might ended up neglecting the dogs, she said, she will get homes for them, I think we need to Inform the Law Enforcement officers, with regard the unsterilized dogs and 14 dogs onto the property.

We have proceeded to the back of the Wendy house, where was a dog called meisy, the dog belongs to Nazeels brother, who was not at home during the inspection
The dog appeared to have skin condition, the the dog was chained up with a short chain. The living environment was dirty

As the Nazeel was not happy with the condition of the dog , she told me take the dog and sje also told me that, she is willing to sign the admission, I have called Rudy, he also agreed with Nazeel, then I took the dog

as unwanted from Nazeel

Because of the discussion whether I seized the dog or i take the dog as a surrender i ended up forgetting

Issue the warning based on the living environment as well as the dogs condition.

This case need to be reffered to our Law Enforcement officers to address the unsterilized issues as well as the number of the dogs on the property.

Follow up to be conducted next month.
