74 Burns Road Salt River, Cape Town.

The breeder had an old person living with him (grandmother) who came out and bragged to me of his breeding dogs 'in the back' - and he immediately tried to shut her up.

If you look at an aerial view of the property there are a whole lot of structures in the backyard.

It should be investigated for keeping dogs in cruel conditions as a starter.
