Upon arrival, myself and Cadet Inspector Yaaseen Abrahams met with Jayden, who is the owner of the dog and who gave us access to the property. We observed a Black/White adult female Pitbull X dog, fair body condition, tied on a chain of approximately 5 metres in length. The dog had access to shelter, was slightly broken but the owner has closed it up temporarily, and access to clean potable water.

Jayden informed us that he has ordered the cable required for the running chain already, however he is just waiting for it to be delivered. He says it should hopefully come within next week and he will keep checking with the shop when it arrives. He also showed us the new shelter they built for the dog, due to the current shelter starting to break apart. He says they will be moving over the new shelter within the next few days, as he still wants to make some adjustments.

Cadet Insp. Yaaseen advised Jayden that we will then follow up for the running chain and the shelter both at the end of next week to give him ample time to get both sorted, and should any delays occur with the chain being delivered then he should contact the SPCA to inform us of such.

Cadet Insp. Yaaseen issued a notice to comply instructing the owner to:

1. Place the dog named "Girlie" on a running chain which is at least 5 metres in length within 7 days
2. To contact the SPCA if any issues arise on the number provided on the notice
3. To replace the current shelter with the new, more sturdier shelter within the next 7 days.
