General Report Comments: At the time of inspection I met with owner and addressed welfare concerns received regarding the animals on the property and he allowed me inside the property to conduct an inspection.

I observed 2 x dogs free roaming inside the property in an area that affords sufficient space for the dogs to exhibit behavior. The old brown dog appeared to be have a skin condition and it was old as well which owmer claimed he did call AACL to collect but was told that they don't pick up, he asked if I can take the dig which I told him we can do the paperwork after the inspection. Ghe other dog xbreed black/white appeared to be in fair condition however being incintact with the dog with a skin condition made him scratch himself constantly which I advise they need to seek vetinary attention for the dog in question and he agreed to do so.

We went inside the house and he showed me a room where he keeps a GSD type young dog in a room that still was spacious however the environment was filthy as well high needed cleaning. He claimed ghat the dig with skin condition does nit her along with the puppy but he will let the dig stay with the other now that the old dog us leaving.

We did the paperwork for the dog and I gave him a warning stating that :

1. whenever you have a sick or injured dog to seek vetinary attention without any delays
2. Seek vetinary attention for the dog kai that appeared to be scratching itself
3. Clean and well maintain living conditions of the GSD

NB: COMPLAINANT NEEDS TO GO TO THE POLICE STATION IF SHE DOES INDEED CLAIM THE DOG IS HERS WITH A COPY OF OWNERSHIP IF THE DOG AND INFORM THEM OF THE SITUATION
