General Report Comments: Upon arrival at fifth house no. 4 Haroon street, Pelican Park accompanied by Inspector Bryan Arendse I met Britney Wolmaram owner's cousin who gave us access onto property. The owner of the animals is Sakeenah Moultrie DOB:(1995/06/16) Cell:0609704839. I observed four dogs Biscuit a x-breed adult tan and white (sterilised) male, Bella a x-breed adult black, tan and white (sterilised) female, Zack a x-breed adult black, tan and white (sterilised) male and Sasha a x-breed adult tan, white (sterilised) female who all appear to be in fair condition and alert with body scores of 3/5. They have access to adequate water, shelter and a clean living environment. Deworming and fipronil for ticks was given for the animals.

We then went to the seventh house no. 13 Haroon street, Pelican Park where I met Abdul Jackson owner's son who gave us access onto property. The owner of the animals is AbdulMaliek Jackson (DOB: 1960/03/24) cell:0723079237. I observed three dogs Stacey a x-breed adult tan, black and white female, Rascal a x-breed 8months tan ,black and white, Junior a x-breed tan and black male who appears to be in a fair condition and alert with body scores of 2.5-3/5. They have access to adequate water, shelter and a clean living environment. They were advised to move the steel water bowl to the shade. Deworming and fipronil for ticks was given to the Animals. Owner is interested in sterilization, which will be done once new year starts.

We then went to the ninth house no. 27 Haroon street, Pelican Park where I met Fatima Stringer (DOB:1979/06/01) cell:0726207335 Co-owner who gave us access onto property. I observed three dogs and one cat Nemo a German Shepherd black and tan 1year (steried) male; Nala a German Shepherd black and tan 1year female; Misty a jack russel white, black and tan 4years old (steried) female and Horror a domestic short haired black 6years old (steried) male who all appear to be in fair condition and alert with body scores of 3/5. They have access to adequate water, shelter and a clean living environment. Deworming and fipronil for ticks was offered, but the owner said they do keep up to date with it and so she was not interested.
