General Report Comments: Upon arrival I met owner's daughter who told me her parents are not home. She then contacted her father who told me over the phone that they were not able to take the dog to the vet. I just reminded him that when we take the dog she will not be coming back and that she will become property of the SPCA. He agreed that his daughter can sign the dog over on his behalf, which she did admission no. A48565.

I then observed three completely other grown dogs that I did not previously and that the puppies are no longer on the property. Jamie-lee told me that the puppies has all gone to their new homes. The remaining dogs all appear to be in fair condition and alert with body scores of 3/5. They have access to adequate water, shelter and a clean living environment. I then offered sterilization, but the owner was not interested.

I then issued a NTC for the owner: In future as the owner of an animal ensure when that animal is in need of veterinary treatment it is provided without any delay as denying your animal veterinary treatment is a contravention of the Animals Protection Act no.71 of 1962.
