

RELEASE AGREEMENT

The Cape of Good Hope Society for the Prevention of Cruelty to Animals
("The SPCA")

I, SRN Nieuwehuys. with **Identity Number:** 9006248104086.

hereby confirm that I am the lawful owner of the dogs that were seized by the SPCA in terms of the Animals Protection Act 71 of 1962 (read together with Regulation 468) on 6 ^{March} ~~February~~ 2024 from 84 Heerenweg. The said dogs have been admitted into the care of the SPCA under Admission numbers: A28882 + A28883 (2x dogs).

The SPCA has agreed to return A28882 + A28883 Animals into my care on the following conditions:

1. I undertake and commit to the following:

a. I am over the age of eighteen (18) years of age and of sound mind, with the necessary capacity to act, including to enter into this contract.

b. I freely surrender ownership rights of the following animals to the Cape of Good Hope SPCA and ~~I give~~ the SPCA the full right to deal with the animals in terms of the SPCA Act 169 of 1993:

It is expressly agreed that neither the SPCA nor its officers and employees will incur any obligation to me on account of such disposition of the said animals.

c. It has been agreed that the animals identified as A2882 + A2883 will be returned to my care on the following conditions listed below, and if I fail to comply with said conditions, ~~then I will relinquish all ownership rights of said animal to the Cape of Good Hope SPCA and I give the SPCA the full right to deal with the animals in terms of the SPCA Act 169 of 1993.~~ SB JRN

i. Conditions agreed upon on which the animals will be returned into my care:

1. I clean and hygienically maintain my property by At All Times;
2. The animal is sterilized by the SPCA prior to it being released.
3. I will not keep the dogs in conditions contravening the Animals Protection Act 71 of 1962, in particular Section 2 and its subsections. Including the following requirements:

a. Treating animals for external parasites and rendering veterinary treatment to/for animals in need of such treatment, without delay.

b. I will ensure that my dogs are kept fit and healthy at all times and that do not permit my animals to roam the street.

c. To keep or cause the animals to be kept in conditions that would benefit their welfare and promote their best interests.

d. I herewith consent to the SPCA sterilizing the dog with Admission number A2882 + A2883. I understand that sterilization is a surgery to make my animal unable to produce offspring. I further confirm that I will not hold the SPCA or its officials liable for sterilising/neutering my animal and or any complications resulting thereof, and I authorize the use of anaesthetics and other medications, as deemed necessary by the attending veterinarian.

e. I herewith consent to the SPCA microchipping the dog with Admission number ~~A28882~~ + ~~A28883~~.

f. An Inspector of the SPCA will be permitted to inspect my animals at my premises at any reasonable time to ensure their welfare and well-being and to ensure compliance in terms of the Animals Protection Act 71 of 1962.

2. I consent to the Jurisdiction of the appropriate courts relating to the enforceability of this agreement.

I confirm that I understand that this mutual agreement does not preclude me from any criminal prosecution. This is a voluntary mutual agreement reached between myself and the SPCA to mediate the matter without involving the Courts. I understand that the SPCA reserves the right to proceed with criminal charges against me in terms of the Animals Protection Act 71 of 1962 should I fail to comply with this mutual agreement.
