IT IS HEREBY AGREED THAT:

Whereas the Terms and Conditions contained within the Agreement of Lease signed by the Landlord and Tenant at Durbanville on **28 February 2020**, it is recorded that:

1. **DURATION:** The lease is extended/renewed with **12 months** from **1 March 2024** and terminating on **28 February 2025**, during which period the lease shall be on all the conditions contained herein save that the TENANT shall have no right of further renewal.
2. **RENTAL:** The rent for the extended period is **R3 950** per month, payable monthly in advance, on the first day of each month, without any deduction whatsoever, to be paid to the LANDLORD at the offices of GROOT PHESEANTEKRAAL BOERDERY TRUST, or to such other place as the LANDLORD in writing from time to time directs.
3. **SECOND RENEWAL PERIOD:** This lease may be renewed for a second renewal period of **12 months** at discretion of the LANDLORD, provided that notice is given to the LANDLORD of the TENANT'S intention to extend/terminate this lease is given in writing at least two calendar months' before the date of termination. During the second renewal period, the lease shall be on all the conditions contained herein save that the TENANT shall have no right of further renewal. Should the option to renew this lease for a second renewal period be exercised in terms of the provisions hereof, an increase of **7.5%** will be applicable after one year.
