RE: SEIZURE OF YOUR DOGS – CONTRAVENTIONS OF THE ANIMALS PROTECTION ACT 71 OF 1962.

1. Your correspondence is noted and the contents thereof shall form part of the record in your criminal trial in accordance with section 218 of the Criminals Procedure Act 51 of 1977.
2. You are herewith instructed to lay claim to your animals within 7 days of seizure as required by law. Please see the Regulation 468 left with the seizure notice at your premises. You are to claim such animals in person, failing which you will forfeit your rights to them.
3. I suggest that you spend less time and effort drafting incriminating emails, and make more effort to positively advance this matter.
4. I will not entertain recalcitrant correspondence. You are warned to refrain from continuing to do so. You are also warned that any admission made by you pertaining to the elements of the offences and the establishment of facts arising therefrom will be admitted as evidence in Court during the course of your trial.
