Dear Mr. Moses,

We acknowledge receipt of your correspondence sent via the Alberton SPCA. Please note that each SPCA operates autonomously; therefore, we request that you direct any further correspondence directly to this office.

As you are aware, the SPCA has a statutory obligation to investigate all cruelty complaints reported to us. On 12 June 2024, Inspector Rowan Davids had to execute a court order to gain access to your property after you denied him entry for an inspection following a complaint. Your continued non-compliance necessitates our Inspectors to seek court orders for access. Your total disrespect for our Inspectors and our statutory powers is not appreciated, especially since you are a member of the South African Police Service who should be setting a leading example and ensuring compliance with the law. Our Inspectors have previously issued you warnings to ensure compliance with the Animals Protection Act 71 of 1962. Unfortunately, you resort to playing the race card, despite the fact that this issue is about the conditions in which your dogs are kept, not your race. In our last four inspections, we specifically sent an inspector of your ethnic group, and this too was met with resistance.

Your allegation against Inspector Taljaard is defamatory and an attempt to divert attention from your actions. Inspector Taljaard never touched your wife's breasts, as confirmed by a witness who was present. Furthermore, the Department of Public Prosecutions declined to prosecute the matter. We caution you to refrain from making such allegations as we will not hesitate to take legal action against you for defamation.

A follow-up inspection needs to be conducted at your property following the warning issued by Inspector Davids. If you refuse this inspection, we will have no other option but to apply for another court order in terms of the Animals Protection Act, which is our legal right.

We have also copied your station commander and the SAPS Provincial office as your behaviour is unbecoming of a police officer.

Kraaifontein case 735/12/2022 was open against Inspector Taljaard also go touching my wife breasts in front of my children when she did not want him to enter.

Previously the SPCA also received complaints, and our Inspectors were obstructed from executing our statutory powers – this is a criminal offence.

An inspection needs to be conducted of your animals. Either you comply and grant our Inspector access, or we will have no other option but to approach the honourable court for an order in terms of the Animals Protection Act 71 of 1962 to execute our statutory powers.

Our Inspector will contact you in due course to arrange for a site visit at your property.
