**RE: NOTICE TO RECTIFY ISSUES AFFECTING ANIMAL WELFARE AT
GOEDEONTMOETING FARM R304**

1. We refer to our letter 19 April 2024.
2. Our client had hoped that you would have complied with its reasonable demands, set out in the aforesaid letter. It appears, from an inspection conducted of the farm last week, that you have still not made any effort to alleviate the plight of your dairy herd despite the severe weather that had prevailed.
3. Your conduct remains in violation of the provisions of the Animal Protection Act ("the APA"), in various respects. It also falls far short of the requirements of the relevant SABS (SANS) standards and industry-related codes of good practice.
4. There are more cold fronts expected for the area in which your farm is situated. They will no doubt cause further suffering to your animals.

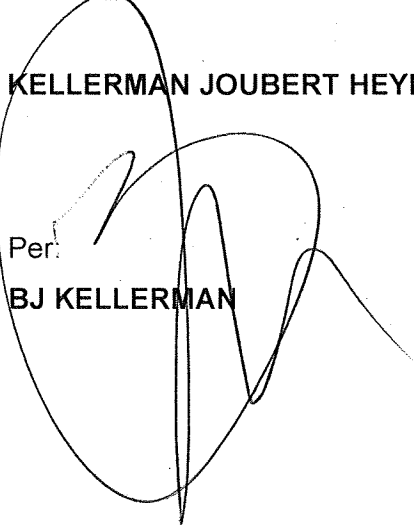

If the required shelters are not erected within 7 days of this letter, our client will brief counsel and will apply for an interdict to compel you to comply with the APA and to prevent furthering suffering. Should you assert that you cannot afford the shelters, then you should sell so many animals as are necessary to raise the funds to afford to do so. There is, in truth, no excuse for your failure to do so and you should have done so when our client first raised this issue with you, in November 2023.
