**RE: NOTICE TO RECTIFY ISSUES AFFECTING ANIMAL WELFARE AT
GOEDEONTMOETING FARM R304**

1. We refer to our letter to you, dated yesterday, sent yesterday, and re-sent this morning.
2. We are instructed that our client's inspectorate received a voice-note from you, via WhatsApp, confirming:
 - 2.1 receipt of our correspondence; and
 - 2.2 that you have contacted your "*stooroprigter*" who will be assisting you to erect a "*stoor*" during next week.
3. For the reasons set out in our earlier missives, our client is extremely concerned with the welfare of your animals. You have had more than enough time to establish shelters for the animals, which would have provided them with some harbour from the inclement weather of the past weeks.

An inspection will be conducted at the end of next week to ascertain whether you have given effect to your undertaking, and complied with our client's demands. Our client expects your full cooperation in allowing them access to the farm to conduct the inspection. If not, our client will exercise its duties under the Animal Protection Act and utilise the remedies available therein to gain access to the farm. Our client will not hesitate to bring the application for an interdict to secure compliance with the APA, should you not have complied with the demands issued to you.

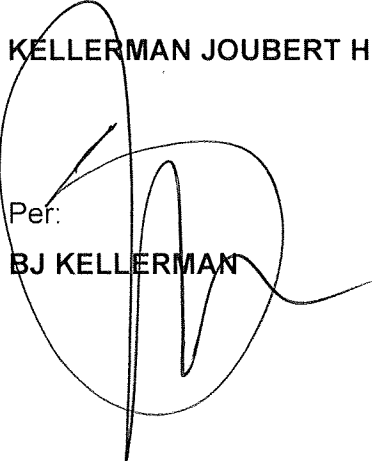
