SEARCH AND SEIZURE WARRANT

[Section 8(1)(a) read with Section 10(1)(b) and Regulation 468 of the Animals Protection Act 71 of 1962]

To: Officer Ayanda Ncgofe

SPCA: Cape of Good Hope SPCA

Whereas it appears to me from the information under oath provided by the officer of the SPCA involved in an investigation into the commission or otherwise suspected commission of offence(s) listed below that there are reasonable grounds for believing that –

A. The following offence(s) have been/are being/are intended to be committed in terms of the Animals Protection Act no 71 of 1962, namely:

Section 2(1)(a) “overloads, overdrives, overrides, ill-treats, neglects, infuriates tortures or maims or cruelly beats, kicks, goads terrifies any animal.” By, neglecting animals (**Domestic dogs**) upon the premises and ill-treating them, upon the premises of **33°31'29.9"S 18°35'02.1"E, of HAWK – HOUNDS (NPC 2024/373702/08)**, by keeping them under such poor condition and denying them adequate care.

Section 2(1)(e) “being the owner of any animal, deliberately or negligently keeps such animal in a dirty or parasitic condition or allows it to become infected with external parasites or fails to render or procure veterinary or other medical treatment or attention which he is able to render or procure for any such animal in need of such treatment or attention...” By, keeping animals (**Domestic dogs**) under offensive conditions, upon the premises of **33°31'29.9"S 18°35'02.1"E, of HAWK – HOUNDS (NPC 2024/373702/08)** by failing to render veterinary

treatment for severely injured or diseased dogs, some of which appear paralyzed.

- B. The articles/animals capable of seizure are concerned and may afford evidence in the commission or a suspected commission of the aforesaid offence(s) are listed as –

Domestic Dogs – Approximately 260

- C. Such articles/animals – Are upon or at the following premises within my area of jurisdiction of 33°31'29.9"S 18°35'02.1"E, of **HAWK – HOUNDS (NPC 2024/373702/08)**. Hereinafter referred to as, "the premises".

And or

Otherwise are under the control of or upon the following person(s) who currently reside(s) within my area of jurisdiction: **Andre Verbiest, Vanessa Van Rooyen Hurt, Ronne Forsythe, Trevor De Bruin and Sharon Claasen. (Directors)**

THEREFORE THERE IS A NEED to search for and seize such articles/animals upon or at the premises/under the control of or upon the identified person(s)

YOU ARE HEREBY AUTHORISED AND REQUIRED within the context of the performance of all relevant duties to –

- Enter the above identified premises and approach the identified persons during the day and search the identified person(s)/premises and any other person found thereupon for the animals/articles as listed, and to seize such animals/articles should it be reasonably necessary to prevent further suffering to such animals that are found thereupon, and exercise any further powers and perform any further duties conferred upon you in relation to such animals in terms of Section 8(1) and Regulation 468 of the Animals Protection Act 71 of 1962.
- Take such photographic and/or video evidence/footage that may be reasonably necessary, for the purposes of your investigation, and/or which may afford additional evidence in respect of the offence(s)/suspected offence(s) committed in terms of the Animals Protection Act 71 of 1962.

Any person whose rights in respect of any search or animal seized under this warrant have been affected is entitled to a copy of this warrant, together with a copy of the supporting affidavit.

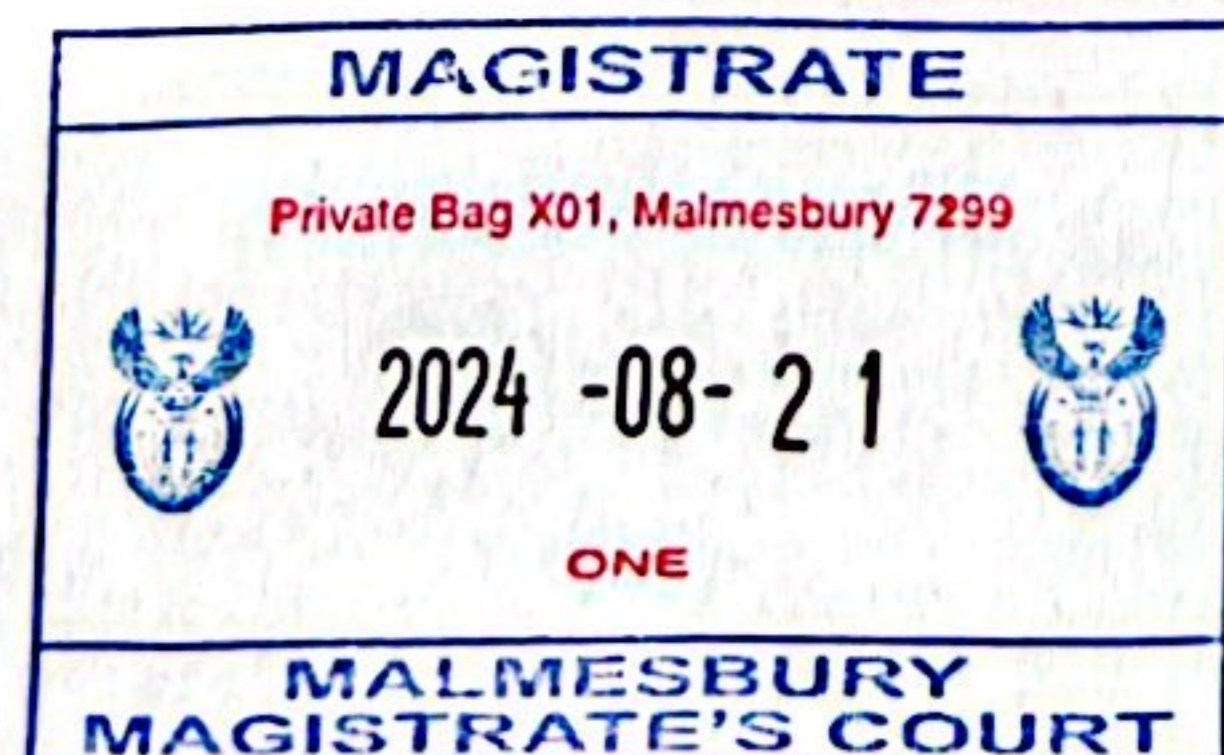
