Accused is Dillon Joseph (DOB 20040303) residing at 24678 Magalies St, Matroosfontein, Cape Town, 7490.

Monday, 08 April 2024:

- Jeffrey will register the docket sometime this week. He will WA once he has handed it in.

Tuesday, 09 April 2024:

- Jeff handed the docket in at Kleinvlei SAPS. CAS 169/04/2024. SAPS couldn't yet provide confirmation of IO.

Thursday, 02 May 2024:

- Called SAPS and case number provided is CAS 169/04/2024. The woman said she didn't have access to details confirming IO. Follow up with CID in 3 weeks. Case registers have been updated.

Thursday, 15 August 2024:

- I received a call from Detective Jacobs. He said the Prosecutor wants the statement from Dillon Joseph, Melony Lindt-Oz (witness – issued accused with warning whilst at Cart Horse Protection Association), and why the docket was registered 7 months after the offence.
- I explained to Detective Jacobs that Dillon Joseph is the accused and as such his statement must be obtained by SAPS. I then explained that Melony's statement was why the docket was registered long after the offence as the statement provided was misplaced and we were unable to again procure her affidavit.
- I explained to him that Melony's affidavit is important because she issued the accused with a warning instructing him not to work his heavily pregnant cart horse.
- Detective Jacobs said he completely understood and asked for Melony's contact details and help in getting the correct address for the accused.
- I sent the contact details of Melony and Officer Mateyisi (LE – present on the day) as well as the accused's address (with a google maps link) to Detective Jacobs via WhatsApp.
