I informed the owner she needs to stop immediately. The owner refused to sterilize the cats, the matter has been reported to Law Enforcement for contravening the bylaws of sterilization, ref: 9118838812

I issued a warning:

It was brought to our attention that you allegedly chained/tethering your cat, refrain from doing so immediately, should we receive any evidence supporting these allegations we may take action in terms of the law animals protection act 71 of 1962.

I see no contraventions of the animals protection act 71 of 1962 therefore this case can now be closed.NFA
