General Report Comments: Upon arrival at the property accompanied by LEO officer Abrahams , we met with one of the owners of the property and addressed the reason for our visit and she allowed us inside the the property to an inspection. She claimed that she knows who called us about the situation but we informed her that unfortunately we only get a complaint and investigate it, we do nit have access to complainant details unfortunately nor do we know who complained.

She claimed that the dogs in question that died which belonged to a lady by the name of Elaine Jones who left the property after the back section burned, she claimed that it was about 2 months ago amd they've been trying to tell the owner to collect the dogs but unfortunately she was making excuses. As per Ghasna the digs were sick and were also aggressive as they were also starting to bite people as well, they tried to call the spca for the collection of the dogs but did not have money towards the collection.

As per Ghasna the alleged dog that was strangled died in the a.m and when accused Brandon Frans went to bury the dig at the back the second dog that was alleged to be beaten with a spade attacked Brandon but he hit it with a spade once and it died as per their claims
We saw the lady that is disabled on the property which unfortunately she is not of sound mind to testify on what she saw.

We observed a dog that belonged to Ghasna Isaacs which appeared to have no water , no shelter against the elements and dog appeared to be getting a skin condition as skin was red. She claimed that she wanted to seek vetinary attention but was unable to seek veterinary attention unfortunately due to financial constraints but was willing to surrender the dog over to the SPCA. She also had a cat with a kitten inside the house which appeared to be in fair condition as well (I offered sterilization and she is keen for the mother).

We went to the back area and saw the dogs that belongs to Brandon Frans which all appeared to be in fair condition however had vetinary concerns as the adult dog seemed to have a burn wound and the puppy skin condition developing. There was no water and no shelter for the dogs as well.

I issued a warning stating that the Brandon Frans should (1)seek vetinary attention for the digs under his control within 24hours (2) ensure water is always available for the dogs (3) provide suitable shelter for dogs within 7days (4)clean up the living
