1. Dogs used for safeguarding may only be rented to PAPA-licensed, PSIRA registered security service providers.

2. *An updated list of all rental clients and secondary facilities must be forwarded to the LO and cc papa.els@westerncape.gov.za, on a monthly basis, so that the addendum can be amended accordingly. The list must be forwarded by the 7th of each month.*
3. *When animals under this licence are moved to a facility not listed on this licence, the licencing officer has to be notified 7 days before the intended movement. This will be applicable to movements of new animals to this facility or movement of animals to new secondary facilities and/or rental clients, as well as movement to temporary facilities, where the dogs will stay for a period of less than 5 days.*
