I have advised them to surrender the dog as unwanted as well as the puppies, it was a difficult decision for them as they were crying, they wanted to know what will happen to the dog as well as on the puppies, I told them that, will depend on the vets. They took the pictures of the admission forms and said, they will follow up especially on puppies. There was a shelter and there was water, the food.
