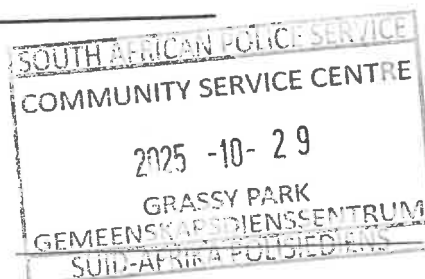

**CLAIMING OF STRAY LIVESTOCK**

(See isiXhosa on the reverse side)

I, Jay Jay (full names & surname), the undersigned, with  
Identity Number: 9512285223082, hereby confirm that I am the legal owner of the stray  
livestock mentioned in the affidavit attached hereto and which livestock has been seized by and is currently  
impounded and in the care of the Cape of Good Hope SPCA ("the SPCA").

**I hereby acknowledge and confirm that:**

1. I am over the age of eighteen (18) years of age.
2. I am the legal owner of the stray livestock.
3. The stray livestock were impounded/seized in terms of section 19(2) of the Animal Keeping By-Law of the City of Cape Town ("the City").
4. In terms of section 19(6) of the Animal Keeping By-Law I am responsible for:
  - 4.1 the reasonable costs of the City, for seizing and removing the livestock, plus
  - 4.2 the reasonable costs of the SPCA, for accommodating (housing, caring and feeding) the livestock; and
  - 4.3 paying these reasonable expenses, before the livestock may be released to me, for such period up to and until the livestock are released to me.
5. I undertake to pay to the SPCA the reasonable expenses pertaining to the livestock, as set out paragraph 4 above, within 7 (seven) days of date hereof.
  - 5.1 Should I fail to settle these expenses in full within 7 days from the date of this claim, I forfeit the livestock to the SPCA, for it to become the sole and beneficial owner thereof, and I consent to the SPCA disposing of the animal/s, as it deems fit, in order to recover these expenses, or part thereof (if any). If any funds are left, after such expenses have been defrayed from the proceeds of the sale of the animal/s, they are to be paid to me into an account nominated by me in writing for this purpose.
  - 5.2 Neither the SPCA, nor any of its agents or employees, will, save for the obligation to make the payment to me (if any) in terms of paragraph 5.1, be held liable for any loss or damage that I may suffer as a result of the disposal of the animal/s necessitated by my failure to settle the expenses mentioned hereinbefore, in full, within 7 days from the date of signing this document.
