- All dogs must receive the relevant training from a SASSETA accredited trainer/facility before being used for safeguarding.
- Dogs used for safeguarding can only be rented to PAPA-licenced, PSIRA registered security service providers.
- Dogs may not be left unattended at a facility during or between working shifts.
- Any restraining/ training or handling methods used on the dogs shall not cause pain, injury or suffering.

- All dogs must be examined at least twice a year by the facility veterinarian and be declared fit and healthy to perform the required work by the said veterinarian.
- Dogs displaying aggressive behaviour towards handlers/public or other dogs must either be removed from service or treated by the facility vet to eliminate such behaviour if possible.
- The licencing officer is to be informed if there is any change to the number of dogs and/or secondary facilities utilized, other than listed on this licence.

This licence is valid from **16 April 2025** until **15 April 2026**.
