He took photos with 2 phones. He confiscated my dove whom Ive cared for many years as the AAFC said it will never fly as its tail feathers were not growing back again..as well as my tortoise.

He informed me to get 7 certificates from a vet regarding my 3cats who have a skin allergy, 3 was a bit underweight(they are also golden oldies, very old) & 1cat who has cancer on her ears

He gave me 72 hours! Which i took them all to the vet with vet approved certificates. No one said anything about having a permit for the dove. If I knew I had to have a permit I would have applied for it. But it was taken by Lee Prince whom surrendered it and the tortoise.
