Please note that this matter was reported purely as the person in question is wanting me to vacate accommodation on their property. Prior to her call to you, her comment was 'just to let them loose' being of feral nature but as I have had them all now for nearly 10 years they wouldn't be able to fend for themselves in the wild and to me, this would constitute abandonment.

My animals are my family and treated as such.

They are fed twice a day namely 7pm & 6pm

Cats - Feline Cuisine & the dog - Optimizer Premium.

During the day, the cats have access to both the house & garden that is fully fenced in.

The dog, has access to an undercover verandah and a covered kennel and happily sits on her bench viewing the surrounds.

In the evenings, once it become dark they are all brought in to settle down for the night and sleep

My pets are not allowed to free roam as I stay on rural land that could have predatory animals lurking around.

The area fenced is of similar size to property plots currently being sold on the open market

Sera is kept safe and walked upon my return from work in the evenings, not unlike the majority of public do

Food and water for all is always readily available.

Their constitutional health is always of my main concern

I love my pets and take responsibility as Guardian very seriously, and I am horrified as to having had an inspector called out on me for whatever reason. Please let me know what else I must do
