FINDINGS

Confinement of animal/s: Free roaming - in property
Adequate space: Yes

Upon arrival, myself and Inspector Lee Prins from the Cape of Good Hope SPCA met with the owner, Mr. Therry Jacobs, who granted us access to the property. I observed 4 dogs in total on the property, with 1 cat. All the animals were free roaming on the property, clean living environment and all in fair body condition. However, there was no shelter seen, and the water bowl for the dog was empty. I asked the owner where the shelter for the dogs is, as the cat sleeps inside the house. The owner replied to say they have not built another shelter for the dogs as the last shelter they had was stolen piece by piece. I told him that he will need to find a way to make sure the shelter is secure as the dogs require shelter. He also needs to ensure the dogs have access to clean potable water at all times, as the bowl for water is currently empty. The owner acknowledged the requests.

I issued a warning notice, 21837, to:

1. Provide the animals with adequate shelter against the elements within 7 days.
2. Provide the animals with sufficient potable water 24 hours a day

The warning was co-signed by Inspector Lee Prins and I, and was signed and accepted by the owner Mr. Therry Jacobs
