FINDINGS

Upon arrival, myself and Inspector Lee Prins from the Cape of Good Hope SPCA met with the owner, Mr. Reginald Hendricks, who granted us access to the property. I observed an adult female dog, fair body condition but heavily pregnant. The dog is free roaming on the property however the living area has a few hazardous materials laying around. We could not find any water available for the dog as well, however the dog had access to adequate shelter. The owner told me they busy renovating on the property, that's why there are hazardous materials like wood with nails in them laying around. He also said the dog has a water bucket, but he doesn't know why its missing now, but he will get another one now. As I was looking at the dog I noticed a tick on the back of her neck area. I told the owner I will give

the dog Fipronil for the tick, but he needs to clean the area of the hazardous materials and ensure the dog has clean water available at all times.

I issued a warning notice, 21832, to:

1. Provide the animal with sufficient potable water 24 hours a day.
2. Ensure the living area is clear of any hazardous materials within 7 days.

The warning was co-signed by Inspector Lee Prins and I and was signed and accepted by the owner Mr Reginald Hendricks. I asked Reginald about sterilization for the dog, and he said he definitely wants to have her sterilized but shes very soon going to give birth. I told him we can schedule it for once she gives birth and the puppies are weened. I also administered Fipronil on the dog for protection against external parasites.
