FINDINGS

Confinement of animal/s: Free roaming - in property
Adequate space: Yes
Clean living environment: Yes
Water available: No ***
Adequate shelter available: Yes, but not adequate ***
Animal/s in good condition: Yes

Upon arrival, myself and Inspector Lee Prins from the Cape of Good Hope SPCA met with the owner, Mr. Ashweldo Pietersen, who granted us access to the property. I observed two adult male dogs, fair body condition and free roaming on the property. The dogs had a water bowl but it was empty, and there was one shelter outside. The owner advised that the one dog, Max, sleeps and stays inside mostly and the dog Jackie stays outside always, and the shelter is for him. However, the shelter was quite small compared to the size of Jackie, and we made mention of this to Ashweldo. He also then showed us a male puppy dog inside the house, fair body condition with access to water and adequate shelter.

I issued a warning notice, 21830, to:

1. Provide the animals with adequate shelter against the elements within 7 days.
2. Provide the animals with sufficient potable water 24 hours a day.

The warning was co-signed by Inspector Lee Prins and I, and was signed and accepted by the owner Mr. Ashweldo Pietersen.
