

I, Bradley Salt, would like to provide the official statement regarding the occupant of 1 Clipperbon Close, Capri Village and his treatment of the wild Peacock that frequents the property that I live on. There are several peacocks that visit the property, one in particular sleeps in a tree on the property at night.

In June 2025 as I was getting out of my vehicle I was approached by a man. He began complaining about the peacocks and the sounds they made at night. He asked me if they bothered me, I answered no. He then said that he was going to ask one of the neighbours to use a hosepipe to spray them to scare them away. He claimed that they bothered him and he couldn't sleep.

In June 2025 I was sitting outside at 8pm having a ~~cigare~~ cigarette and I noticed a green light in the tree. I went to look to see what it was and saw that it was the same man that spoke to me in June about the peacocks, he was pointing a green laser pointer at the peacock, attempting to stop the peacock from making noises. I confronted him asking him what he was doing, he responded by shouting that the noise the peacocks make was keeping his wife awake. I told him to stop and he did. I did not see it happen again until October.

In October 2025 I was outside having a cigarette, ~~when~~ clanging noises above me suddenly

started. Then I saw stones coming over the wall landing in front of me. I payed attention to see where the stones were coming from and saw that they were coming from the ^{some} direction that the lazer pointer had come from. I went to see if the man was there but he was not. That same night I saw him using the green laser pointer again. I confronted him again and he stopped for the evening, however after that night it happened regularly. I would see the laser pointer and see that it was the man pointing it at the peacock.

My sister, Tamara Kilian, arrived from Australia to visit my father and myself for a month, on the 29th of October. On the evening of the 30th she called me to ask me what the green light in the tree was and that she had seen it three times in two nights. I told her that it was a laser pointer and that the man was trying to scare the peacock away. I confronted the man once again and told him that I was going to report him to the SPCA. He responded by saying that the SPCA told him that he was allowed to do it. My sister then emailed the SPCA asking advise on the matter.

I live with my father who owns the property on 46 Capri Drive, Capri Village. His name is Robert Salt.

The property belongs to my father, Robert Salt, and my brother, Bradley Salt, lives with him.

I arrived in South Africa on the 29th of October to visit my father, Robert Salt, and my brother, Bradley Salt, from Australia. Over the evening of the 29th and 30th October, while I was standing outside looking at a peacock in a tree, I noticed a long green light appear in the tree, directed at the peacock. This happened 3 times. I asked my father and brother what it was and they informed that it was the neighbour behind our house pointing a laser pointer at the bird to scare it and stop it from making noises. They said it happened frequently, and that the man also throws stones at the peacock. My brother also told me that the man had said he was going to ask the people that live next door to spray the bird with a hose pipe.

On the evening of the 30th October when the man was pointing the laser pointer again, I called my brother and he went to tell the man to stop.

~~He responded.~~ My brother told him that he was going to report the man to the SPCA, the man responded saying that the RSPCA told him he was allowed to do it because the noise the peacock makes keeps

him and his or wife awake during the night.

It was then that I decided to report the man's behaviour to the SPCA as I was afraid that the laser pointer would cause the bird to go blind.

There are more peacocks visiting the property and I fear for them too.

The original peacock did not come back for a week after the 30th and has since only been twice.

The property belongs to my father, Robert Salt, 46 Capri Drive, Capri Village. My brother, Bradley Salt, lives with him. I will be going back to Australia on the 27th November.

I hereby declare under oath that the information provided in this statement is true and correct to the best of my knowledge and belief. I am aware that any false statement made by me may constitute an offence under the law.
