The dogs are running all over 1 brown one, 3 black young dogs and a brindle color young female. the females are not sterilised and they just produce more and more puppies. There are 5 or 6 black little puppies running around in and amongst trucks and a pit bull that is tied on the other side of the property and apparently this dog is very sick too. There used to be white dogs locked up in the small courtyard as u get to the house but not sure if they are still there, they also had dogs in cages as well but not 100% sure if that is still the case. I refuse to go there as I cannot deal with the dogs that are not being cared for the way they should be. I would love to feed them but cannot encourage them in my workplace.

Over time, I have witnessed a growing number of cases involving neglect, uncontrolled breeding, poor living conditions, and animals left without proper shelter, food, or medical care.

It is deeply distressing to see these animals suffer , and the situation appears to be worsening. These residents do not seem to follow basic animal-care standards or the legal requirements regarding pet ownership, breeding, and the number of animals kept on a property. This creates ongoing cycles of neglect and unnecessary suffering.

I kindly request that the SPCA or Law Enforcement make a concerted effort to make sure that by laws are adhered to. I also believe that clearer guidance to residents on legal responsibilities and welfare expectations would help prevent many of these problems.

I understand the SPCA works with limited resources, and I truly appreciate the difficult work you and your team do. My intention is not to criticise but to bring urgent attention to a situation that is causing

visible harm to the animals in the community. I hope we can work together to improve their welfare and prevent further suffering.
