Upon arrival at aproxmatley 14H20 myself and inspector davids was given access by Manager Qhayiya  
We checked the food storage area and the chemicals where removed and no longer stored close to the food in the container all apeared to be in order  
We then moved over to the Yard area where the dogs are kept when they rest in there enclosures the two dogs only work night and come back in the day to rest at the red Ant head office  
The kennels and the enclosures belong to Cape canine they Services them  
We then met with the kennel master Terry Dyantyi  
The enclosuree where together before they put a space between it to prevent the dogs urine from

passing through the cages

They also put on shade cloth on top

The length of the enclosure is 298cm, the height of the enclosure is 180 cm and the breadth is 200cm

The kennel master took the first dog out the GSD tan black in color named Bella she appeared to be in a fair condition , the enclosure was clean , she had fresh water , i lifted the kennel up it was clean under the kennel

Last time in the kennel floor there was Protruding Nails

That was gone

Dog 2 , Rottweiler male Named Franko tan black

The kennel master took him out of his enclosure he appeared to be in a fair condition

His enclosure was clean and had fresh water

The broken floor in his kennel was fixed they complied

With that I lifted the kennel it was clean under the kennel

All was in order with the kennels and enclosures at the head office belonging to Cape canine

The Manager Qhayiya Nkuzo informed me that the shade cloth was not set up at the Macassar sand me and said that Cape canine was suppose to do it today
