FINDINGS

Upon my Arrival at aproxamtely 10H53 Myself and inspector davids was given access by the operational manager Kayla , she told us the cats get fed twice a day and that they get fed chicken as we entered the park on the left was the first enclosure , this was the enclosure For two female Bengal tigers both sisters and white and black in color
We start with a walk around the enclosure it was as natural as possible
There was adqaute wooden structure shelter build
They had a automatic water truf
The enclosure was clean
When we where done with the enclosure one of the park members was about to feed the tigers
We noticed a blue chicken we informed Kayla Immiadately so it doesn't get fed to the tigers
Kayla informed her member about the concerns they then complied the chicken was in a wheelbarrow

At the same time a visitor at the park had thrown a stone at the leopard , Kayla told us about this and we then found out who the visitor was , we found the person it was a male tourist from Feji by the name of Emosi Mulevoro approximately 38 years old we educated him on the law and issued him with a warning to Refrain from throwing any animals with stone or objects warning number 23910
The leopard was not harmed

We then made our way to the enclosure of the black leopard adult male who was laying in the grass and appeared to be in a fair condition
There was access to a nice wooden shelter
This black leopard also had a automatic water truf clean and adqaute , the enclosure looked as natural as possible
Kayla informed us that all enclosures are cleaned
On a Tuesday and Thursday

We then came to the third enclosure this was for the orange and black leopard in color male , it had automatic water truf on the side on the enclosure a shelter made of wood and enrichment , it was clean and he appeared to be in a fair condition

The fourth enclosure had and adult female white lioness in it , she appeared to be in a fair condition and was moving around natural there was enrichment for her , she had a automatic water truf which was clean she had shelter and the living environment was clean

There was a fire break , the enclosure where shaped like a block in the cat park with adqaute space
The fith enclosure had
Two lions a male and female in it who both appeared to be in a fair condition There was a automatic water truf , they had a wooden shelter big enough for both of them
The sixth enclosure had a tiger in orange and black in color who appeared to be favoring its left back leg finding it hard to put pressure on it , Kayla Immiadately contacted her boss to get the vet out to come check it out it was a male tiger
His living enviroment was clean
He also had automatic water truf and a wooden structure

We then issued a warning
To remove all rotten chickens when feeding the cats with the fresh ones
Seek veterinary care for the tiger in enclosures 6
Within 48 hours warning 23911
