Buddy's dog daycare and boarding is run by both Shelly Voorn and Meagan Durant who both have prior experience in dealing with animals. The day care runs from 6:30am - 6:00pm with a total of 8 staff members. The day care takes up to 55 dog a day, each dog owner has to fill in a form stating where and when their animal had been vaccinated and sterilized. Shelly had advised occasionally she has sleepovers with a max of 10 dogs which stays over. Each animal has adequate space to move around and enough shelter food and water for each animal.
