There was old faeces in the yard and the owner said that he had been sick and had neglected to properly clean the yard daily. He also said he hasn't been working since last year August and that is why he hasn't been able to buy the wire for the running chain. I did inform him that he was issued a final warning and he has failed to comply fully. I told him that I will be coming back next week Tuesday for the final check and if the one pitbull is not on a running chain by then we will be applying for a warrant.

He then suggested that he will give the dog to his cousin if he is not able to get the runner sorted by then. I also told him that he must clean daily and maintain the living environment. I could see that he was cleaning before I had arrived but had not finished yet.

All the dogs have adequate shelter available.

I will follow up next week Tuesday to check if he has complied.
