There was a room with no door that can be used as form of a shelter by the dog called KK, there was no water provided to KK, I instructed the owner to provide the dog with water at all times.

There were about 20 Pigeons, that were kept into the loft that appeared to be clean and adequate. The Pigeons appeared to be in a fair condition, inside the loft there was clean water and mielies as form of food.

The puppy was no longer at the property, i wanted to know where the puppy was taken to, I was told the puppy was sold to some who reside in the RDP houses .

Then I told them to show me the new address, then we drove to or proceeded to the property where the puppy sold to, which add 145 Milky Way OceanView.

On my arrival, I met with a woman who Monique, who is now a new owner of the puppy.

I inspected the puppy that appeared to be in a fair condition, there was food and there a tin food, I advised the new owner to take the puppy to the vet in order to be vaccinated, she agreed and said, by Sunday she will take the puppy to TEARS mobile clinic.
