He didn't seem to care at all.

He told me that i can just take the dog named Storm.

I encouraged the dog to get up and walk on the leash. It stood up and just collapsed. I picked up felt that it was very light in weight. It is a medium to large dog, however, i could hold it with one hand. It just collapsed in my arms as well.

Rashied signed the dog over without a care at all.

Although water was provided and the living environment was clean, the was no shelter provided.

I issued a stating that he has contravened the Animals Protection Act by denying his dog veterinary attention and treatment.

I rushed the dog to the SPCA hospital and requested for immediate medical assistance and Vet's report.
