General Report Comments: I was allowed access to the property by Meagan and Traswell.

Meagan informed me that the young dog, Nigga, was baited and provoked last night by youths walking past the property with their black and white bull terrier dog. According to an eye witness that lives opposite, in the flats, the young dog managed to escape the property/slip through the fence and was then attacked by the bull terrier and also kicked by the youths, resulting in its right front paw being injured. Meagan told me that the youths always provoke her dogs when they walk past.

I advised her to get affidavits from actual eye witnesses and to let me know once she has it. I told her to have them include as much detail of what they saw happen.

Meagan told me that they are waiting on their cousin with a car to take the dog to the SPCA. I advised her about the importance of having the dog examined as soon as possible.

The dogs had access to a clean living area and there was water in the shade. The other dog on the property appeared to be in a fair condition.
