Incident of Dog being burned
Events of the 5th of June.

On the 5th of June 2025 I, Ingrid Philips received multiple Whatsapp messages and phone calls from my niece Tatum, stating that Bones, her dog was crying and wet in his kennel refusing to come out. According to my niece, her husband, Quentin Pedro, asked Wayne Gertse, our neighbour what happened to the dog and Wayne admitted to burning Bones with boiling water.

Upon receiving this news, I obtained Wayne's wife, Patience Gertse's contact details. I was very emotional at that time and at first sent Whatsapp messages which I deleted, then phoned Wayne from the school's library and asked them what had happened to my niece's dog and Wayne admitted that he burned Bones with hot tea. I was in

Such an emotional state that I left work without permission from my superior. Upon returning home at 3:00 p.m. we found Bones in his kennel, refusing to come out. Given his ~~unusual~~ unusual behaviour and the visible signs of distress, we immediately sought help.

We contacted the SPCA and lodged a formal complaint. Due to Bones' condition and reluctance to leave his kennel, we were unable to take him to the vet immediately. However we did receive assistance from Jeremy Braaf from DARG, who provided us with burn spray to help alleviate Bones' suffering.

Bones, Tatum's dog, has suffered burns on his left ear, the inner ear and outside, his neck had been burned and his back.

This incident has caused significant distress to our family.

On Thursday June 5 2025, I was taking a afternoon nap when I was awoken by my dogs distressed cries my husband immediately got up and ran outside to go and check and that when we found our dog laying on the ground just crying and there was hot steam coming from his body, ~~but~~ he was in abt of pain. My brother Ciaran Philips and his girlfriend, who resides at the property was also present trying to figure what has happened. After my husband returned from a quick run ~~off~~ to the shop, he noticed our neighbour standing on the roof. He then went outside to ask Mr. Gertse if he had burned our dog because the sand was wet. Mr. Gertse had a red t-shirt and red cap and Mr. Gertse replied "Yes i did burn your dog". However Mr. Gertse claimed that our female dog was at his window, which contradicted the fact that my male dog was burned was boiling hot water or oil.

We immediately attended to our dog who was soaking wet was and was burned ~~wa~~ with boiling hot water or oil and was in

a significant amount of pain. I called my aunty and she then told me to contact SPCA. After emailing SPCA we contacted Jeremy Braaf and got spray for the burned wounds that was on the inside, outside his ear down his neck and his body. It was not nice to see my dog suffer like and that the scars would remain for life i cry day in and day out for what has happened it's unfortunate and unfair

On Thursday June 5, 2025, at approximately 13:10, I was awoken by the distressed cries of our dog bones that was in so much pain. Upon investigation, I found our dog wet and incessantly the wetness was so hot the steam was still coming out. I then spoke to my brother-in-law Claron Philips, who resides on the property and he said he also heard the cries of our dog and went outside immediately to go and check but saw nothing. I took a quick run to the Shop. after visiting the Shop, I returned home to find our neighbour Wayne Gertse, standing on his roof, wearing a red t-shirt and red cap. Upon re-examining the scene, I noticed wet sand and asked Mr. Gertse. He claimed our female dog was near his window, but I pointed out that the injured dog was our male dog which makes no sense. When I asked Mr. Gertse directly if he had burned our dog, he replied "Yes, I did burn your dog." I then withdrew myself immediately to avoid further confrontation. My wife then contacted her aunty Ingrid Philips to let her know what has happened and Ingrid called Mr. Gertse to find out

Why he burned our dog before that Ingrid told my wife to contact the SPCA after my wife emailed the SPCA we contacted Jeremy Broof from Darg immediately and got spray for the burned wounds on our dog. Bones was burned on the outside of his ear, inside of his ear, down his neck and on his body. He was burned right down his left side this has scared our dog for life and was so heartbreaking to see our dog like this.
