I asked if they walk Tango and I was told they didn't due to his aggression towards people that don't work with him and due to trucks coming and going all the time.

Actions taken? The dog handler/ security guard was made to immediately give Tango water. I thereafter issued a warning regarding the fact that Tango's water bucket had been knocked over and the water therefore emptied.

Follow-up action required? A final follow up inspection will need to be conducted to ensure that Tango's water bucket has been secured to the kennel so that it can't be knocked over again.

Notice or warning issued? Warning 20055 was issued to Mr Nqobo for both Eastern Guard Security and Cape Canine Services instructing that it is to be ensured that Tango, the working Rottweiler dog on site, is provided with water at all times. Further comments included that a suitable non-tip water receptacle must be used so as to prevent Tango's water from being knocked over thereby leaving him without access to water.

16. COMMENTS

Warning 20055

You are hereby warned to provide the animal with sufficient potable water 24 hours a day.

~~The dog named Tango was found without water as his water bucket had been knocked over.~~
