They have improved over the years. They pointed out the shade provided to the animals. This had previously been a concern which is now rectified.

The handling was done humanely and done with care. The slaughtering holes had constant water running so everything was clean. They gave the animal more time than what is required to bleed out.

They concluded their slaughtering today and no animals were left behind. This matter to be considered closed.
