Subject: Complaint dogs seizure by the spca Grassy park for allergies

Good afternoon trust you are well .

On the 16th of July 2025 my 2 pitbulls were removed from my property at 27 Prince William Street Southfield by Inspector R.Davids of the Spca. He was accompanied by Law enforcement and Saps.The warrant was for the seizure for Xavier the male pitbull. The inspector then stated that he will remove both pitbulls. Of which he did.

Xavier was treated twice at the SPCA for allergies in April 2025 .I was instructed to change his food to Hills scientific plan I told the spca that it's very expensive and we cannot afford it on only 1 salary.They then recommend Montego Karoo as an alternative. I went to the pet shop on the 25 April 2025 as my husband gets paid then.We bought Libie good food which contains Aloe Vera . Xavier however did not take to the new food.We then went to the pet shop and looked for another veterinary formula and bought Jock exceptional nutrition.

The final warning to bring Xavier to the Spca was given on the 7th July 2025.Stated if you not able to comply with the above mentioned then consider surrendering the animal over to the Spca.3 days was given from the 7th July.I emailed the Spca on Monday 14th July to explain to them that I am sick with the flu as I got wet on the 4th July I went to plumstead .I walked in the rain.I am still not hundred percent over the flu. Inspector David's stated that I can't be sick for a month and not bring Xavier to the Spca. I have to walk Xavier on a leash down to the Spca as we don't have a car and the indriver and uber will not take pitbulls. Inspector David's stated in the warrant that it's not a valid excuse so if I walk my dog in the rain then I will get a notice for that as the dog will get wet and sick. My 2 dogs were removed from my premises because of allergies not a good reason as my dogs are not abused.We are responsible pitbull owners. Our dogs sleep inside. They get food and clean water everyday. Please Spca show me the actual abuse and a valid reason too remove our pitbulls . I Was at the SPCA on Thursday 17 July 2025 and received no feedback.I asked if I may please see my dogs and was told no not possible.No valid reason why not.Today Friday 18th July I was told to come back to the spca and I had to fill in claims forms for both pitbulls. I Asked if I could see my dogs and I was given the same answer No.I was then informed that the Spca would have a meeting on Monday 21 July 2025 to discuss the matter.We have not seen our dogs since Wednesday . We just hope that they are OK as they not use to be confined to a space of been locked up they have the free run at our home. The pitbulls are Xavier male and Coco female

I will await your reply.
