FINDINGS  
Confinement of animal/s: Free roaming - in property  
Adequate space: Yes  
Clean living environment: Yes

Upon arrival, myself and Inspector Davids introduced ourselves and explained explained that we are going door-to-door conducting routine inspections. The owner Mrs. Natasha Carrollisen then allowed us access to the property.

We observed 5 cats in total on the property. There was water available to the cats, there were no hazards that we observed, there was also adequate space available to the cats and they had access to the house for shelter where they slept at night. the owner informed us of two cats that she was concerned about. We observed the two cats and the first one appeared to have glossy eyes with a little

bit of discharge coming from it. The owner also mentioned that she heard the cat sniffing slightly as well. The second cat we also observed and saw that there are lesions and wounds concentrated around the cats nose.

The three remaining cats appeared to be in a good condition and a fit and healthy state. We did however explanation to the owner that if she sees discharge from these cats or hears sniffing then she should take them to a veterinary clinic without delay.

We informed the owner that both cats will need to be provided with adequate veterinary attention within a certain timeframe which will be stipulated on the warning that Inspector Davids will issue.

We asked the owner if her cats are sterilised and she informed us that 4 of the cats kept on the property but the one cat named Black Cat was yet to be sterilised. The owner had stated to us that her daughter who is under the age of 18 is hesitant to have the cat sterilised, I informed the owner that her daughter is not yet of a legal age to claim ownership of the cat. I also then explained that in terms of the City of Cape Town Animal Keeping Bylaws it is unlawful to keep an unsterilised dog or cat over the age of six months and a permit is required from the City of Cape Town to do so. further, I informed the owner that she will be liable to be fined and not her daughter.

I then offered free sterilization and the owner was happy for the Cape of Good Hope SPCA to provide that service. The cat will be collected for sterilization upon follow up to the property as Hospital theatre was under renovation for that period of the week.

A warning was issued by Inspector Davids to:

1. Your cat appears to be sick, take it to a veterinary clinic within 48 hours. your Ginger/White cats appears to have wounds/abrasions on the nose, take the cat to a veterinary clinic within 48 hours as well and provide proof thereof for both.

The Owner signed and accepted the warning.
