Upon arrival, myself and Inspector Davids introduced ourselves and explained that we are going door-to-door conducting routine inspections. The Owner Mrs. Rugeeda Fisher then allowed us access to the property.

We observed a 2 month old puppy on the property that appeared to be in fair condition. there is a large verander on the front of the property that appears as though it would provide adequate protection from weather conditions and in addition, the puppy sleeps inside the house and has access to the inside of the house daily as the owner is always home or the grandmother.

The living environment appeared to be clean, there was adequate space available but there was no water present for the dog. We explained that the dog should have water 24 hours a day and it is an offence in terms of the Animals Protections Act 71 of 1962 to unnecessarily deny water to any animal.

A warning was issued by Inspector Davids to:

1. ensure water is available at all times.

The owner signed and accepted the warning. A follow-up inspection will be conducted to check if the owner is compliant in terms of the warning that has been issued.

Legislation:

Section 2(1)(c) of the Animals Protection Act 71 of 1962 for unnecessarily denying water to the puppy kept on the property.
