Please see below:

I would like to report animal neglect. It's two German Sheperd dogs at 15 Limpopo Road (Corner of Limpopo and Sabie Road) Bonnie Brae, Kraaifontein. (Near Kraaifontein Spar at Brighton Centre). Tonight 5 August 2025 at 22h30 I was driving past the house and saw the 2 dogs lying outside in the cold weather. I could not see any shelter like dog kennels (hondehokke) or soft warm bedding for them to ly on against the cold weather. They were lying on the cold paving, I could not see any warm protection like blankets. I was trying to get hold of the owner, by shouting at the gate. I saw the lights inside the house was on, but nobody came out. The dogs were barking at me. So while the dogs were barking, nobody came out to check on the dogs. Which let me wonder if they are leaving their dogs alone at home, outside in this cold. I walk past their house on a regular basis and the dogs are always outside. About a month ago it was raining quite hard and they were lying outside in the rain, soaking wet. It looks like they are alone at home during the day. It seems that the dogs are just being kept as guard dogs (watch dogs) and not as pets (part of the family). Please inspect to see that they have warm and appropriate shelter and warm blankets and soft bedding to sleep on.
