Hi there

Okay I managed to get hold of the owner on WhatsApp.

She is ignorant not necessarily cruel.

The wound was caused by a metal plate gate that was opened onto her foot by one of the children.

She yanked her paw out and ripped it open.

She did clean and bandage the foot and kept her inside but Linkie kept on biting the cloth off.

She was fed some chicken bones and started having diarrhea and blood in 'n stool last night and her appetite also declined.

I explained that we cannot be sure what the cause is of the decline in her condition since it can now be a number of things ie infection in the wound, rust from the metal plate, possible intestinal injury due to chicken bones, she is an old dog so could be Parvo and on top of all of that she gave her one of her own anti-biotics.

She now understands that since she is unable to safely take her animal to the mobile clinics in Delft and cannot find any transport to go to AAACL for treatment that the best option is to humanely euthanise her.

Please collect Diana at B89 (067 920 2133) for safe passage.

Vicky too will ensure that you are safe.

I have put other eyes on you as well for extra backup.

Please note that we have attempted to contact the owner several times, but have been unsuccessful. We are unable to send a driver to the area to collect a dog for euthanasia without the owner's consent, as she previously refused when informed that you would call the SPCA. Ideally, this situation would involve withholding treatment, as she has not taken the dog to the vet.

Please collect dog with terrible wound to foot for PTS.

She spoke to me on Saturday asking for advice. I told her I can call the SPCA for PTS collection but she refused. I then told her how to clean and dress the wound and to send me a pic.

I did not hear from her again – she also did not bother to bring the poor dog to our outreach on Sunday (3 Aug). Instead she remained quiet until late last night. She is now talking about a dog who has blood in the faeces.

I am not sure if it is the same dog but the dog with the (What looks like a deep stab) wound to the foot MUST definitely be collected see attached picture. She must be in agony!

I have ALWAYS had problems with the P, Q and O block people. In all of the 13 years we have operated in Blikkiesdorp, they point blank refuse to bring their animals for treatment, even though it is for free.

There seems to live a culture in that part of Blikkies to be extremely cruel to their children and animals alike.
