FINDINGS

Confinement of animal/s: Free roaming - in property
Adequate space: Yes
Clean living environment: No ***
Water available: Yes
Adequate shelter available: No ***
Animal/s in good condition: No ***

Upon arrival, Inspector Davids and I introduced ourselves to the owner and informed them that we are conducting door-to-door inspections in the area and the owner granted us access.

We observed 3 adult dogs on the property and 3 adult cats as well. All but one of the animals appeared to be in fair condition. The black/tan/white xbreed dog appeared to be slightly underweight. this dog also had an amputation from an injury that had occurred but the dog appeared to be very comfortable and the wound was fully healed as it had happened a while ago already. The shelter area appeared to be dirty and needed cleaning, there was adequate space and water available. Two of the dogs also did

not have any shelter available.

I gave dewormer and fipronil for fleas and ticks which the animals may have.

All of the animals are sterilised except the one white/tan dog named Mia.

Inspector Davids issued a warning to:

1. feed your dog named bruno adequately as the dog appears to be underweight.
2. Clean the dogs shelter area within 48 hours.
3. Get adequate shelter within 5 days for Meira and Mia.

The owner signed and accepted the warning.
